Foreword

This European Standard (EN 12467:2004/A1:2005) has been prepared by Technical Committee CEN/TC 128 "Roof covering products for discontinuous laying and products for wall cladding", the secretariat of which is held by IBN/BIN.

This Amendment to the European Standard EN 12467:2004 shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by February 2006, and conflicting national standards shall be withdrawn at the latest by February 2006.

This European Standard has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive(s).

This amendment takes into account Directive 76/769/EEC on dangerous substances and preparations, prohibiting from January 1, 2005, the introduction of new applications of asbestos cement materials.

According to the CEN/CENELEC Internal Regulations, the national standards organizations of the following countries are bound to implement this European Standard: Austria, Belgium, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, Switzerland and United Kingdom. **Teh STANDARD PREVIEW**

1 Modification to the foreword

Delete the following sentence:

"Attention is drawn to the need for observance of EU and/or EFTA and national legal requirements restricting the use of certain materials e.g. asbestos and to the related marking and labelling requirements."

2 Modifications in Clause 5

2.1 Modification 1

Modify the 2nd paragraph of 5.1.1 to read:

"This European Standard covers fibre-reinforced cement flat sheets of type NT (Non-asbestos Technology)."

2.2 Modification 2

Delete the first bullet point of 5.2.1 to read:

Sheets covered by this document are divided into:

- four categories in accordance with their weather resistance (see 5.2.2 to 5.2.5);
- five classes in accordance with their bending strength (see 5.4.3);
- two groups of sizes in accordance with their method of installation (see 5.2.6);

— two levels in accordance with their dimensional tolerances (see 5(394)]-6426-4d66-bfab-f384dd3838ed/sist-en-12467-2005-a1-2006

Type tests for each category are specified in Table 7 (6.2.1).

2.3 Modification 3

Delete 5.6.2.1 and the subtitle 5.6.2.2 to read:

"5.6.2 Release of dangerous substances

For products containing substance(s) defined in Council Directive 76/769/EEC, the content shall be declared by the manufacturer. This applies to substances contained in the original formulation or created during the manufacturing process. In addition see Annex ZA."

2.4 Modification 4

Modify the 1st bullet in 5.7 to read:

"type of product: NT (see 5.1.1);"

3 Modification in Clause 8

Delete from h): ""AT" for products of type AT," to read:

"h) "NT" (see 5.1.1)."

4 Modification in Annex ZA

Modify the 5th bullet of ZA.3 to read:

"NT (see 5.1.1)"

5 Deletion of Annex ZB

Delete Annex ZB entirely.
