NOTE 1 Tissue paper is defined in 4.215 of ISO 4046-4 as a soft and strong, lightweight wrapping paper of grammage generally between 12 g/m^2 and 30 g/m^2 , primarily intended for protective packaging of delicate articles and for gift wrapping.
