#### **New clause**

**8.6** The information supplied by the manufacturer shall contain a Warning that SCUBA complying with EN 250 is not intended for more than one user to breathe from at the same time.

The information supplied by the manufacturer shall contain a Warning, that if SCUBA is configured and used by more than one diver at the same time, then the cold water and breathing performance may not fulfil the requirements of EN 250.
