Foreword

Introduction

In ISO 15876-2 the "base pipe" shall fulfil the dimensional requirements and the barrier is an "add on" giving to the finished product a bigger wall thickness and outside diameter than stated in the standard. In some countries it is common practice that the "finished product" shall fulfil the dimensional requirements of the standard.

This situation creates a problem throughout the world due to different requirements in different countries. The above shows the need to have a common procedure on the market how to deal with this matter.

Therefore an amendment to ISO 15876-2:2003 has been set up to clarify the requirements on dimensions and tolerances for barrier pipes and to create a common procedure how to design and test these pipes.

This amendment to ISO 15876-1:2003 clarifies the definition of the term "pipes with barrier layer" and supplements the amendment to ISO 15876-2.
