1 Scope

This standard specifies a method for the visual examination of relays and contactors. It shall be used together with EN 2349-100.

2 Normative references

3 Procedure

It is not necessary to prepare specimens as defined in EN 2349-100 for this test.

Visual inspection shall be carried out to ensure that the materials, construction, make-up, marking and finishing conform to the product standards. The visual inspection shall be carried out with the naked eye only.
