EN 2349-308:2006 (E)**1 Scope**

This standard specifies a method for testing the coil current of relays and contactors. It shall be used together with EN 2349-100.

3 Test procedures

The rated voltage shall be applied to the coil terminals and the measurement taken within 30 s, and record the coil current.

4 Test criteria

The coil current shall not exceed the value specified in the product standard.
