## AMENDMENT 1

Page 1, clause 0

Add the following subclause:

**“0.3** Provision is made to cover both tractors with the conventional forward facing driver’s position only and those with a reversible driver’s position which is in agreement with current OECD test code practice. For tractors with a reversible driving position, a clearance zone is defined to be the combined clearance zones for the two driving positions. The point of application of the side impact or loading is determined as the mid-point between the seat index points measured in the two positions.”

Page 4, subclause 7.1

iTeh STANDARD PREVIEW

Insert the following new subclause 7.1.3 (and renumber the existing subclauses 7.1.3, 7.1.4 and 7.1.5 as 7.1.4, 7.1.5 and 7.1.6:

**“7.1.3** For a tractor with a reversible driver’s position, the front wheels of the tractor shall be as defined by the manufacturer and the tests shall be carried out in accordance with either 7.1.1 or 7.1.2 as appropriate. However where the front/rear of the tractor is not clearly defined the front wheels shall be assumed to be those carrying less than 50 % of tractor mass and tests shall be carried out in the sequence specified in 7.1.1.”

Page 4, subclause 7.3.2

At the end of the second sentence, delete the full stop and add the following:

“, or, for a tractor with a reversible driver’s position, midway between the seat index points measured in the two driving positions.”

Page 6, clause 9

Insert the following new subclause:

**“9.4** For a tractor with a reversible driver’s position, the clearance zone shall be the envelope formed by the two clearance zones defined by the two different positions of the steering wheel and the seat.”
