Introduction

Earplugs with entertainment audio input use a wired or wireless system through which audio entertainment can be relayed. They may incorporate a radio receiver set or music player for entertainment or allow audio input from external devices. They also offer the possibility to communicate warning signals or messages. The product standards impose a limitation on the reproduced sound pressure level at the ear.

The requirements of this standard are concerned primarily with earplugs with entertainment audio input.

prEN 352-10 is part of a family of standards describing product requirements:
