

Add these symbols following 7.29.

Symbol number	Symbol form/shape	Symbol description/application	ISO/IEC registration number
7.30		Tractor — Front wheel drive — Automatic operation (Front wheel drive is engaged or disengaged automatically based on tractor operating conditions such as travel speed, wheel slip, and brake pedal position.)	2420
7.31		Tractor — Front wheel drive — Braking (Front wheel drive is engaged when brakes are applied at travel speeds above a specified limit. Otherwise, front wheel drive is disengaged when control is in this position.)	2421
