1 Modification to Subclause 4.6 Ergonomic requirements

Add the following sentence:

"The grab- and pull test according to EN 1082-2 Annex A, A6 "Grab- and pull test" shall not be used for chain metal gloves and arm protectors according to EN 1082-1, March 1997."
