#### **FOREWORD**

This part 2 is to be used in conjunction with the latest edition of IEC 60335-1 and its amendments. It was established on the basis of the fourth edition (2001) of that standard.

NOTE 1 When "Part 1" is mentioned in this standard, it refers to IEC 60335-1.

This part 2 supplements or modifies the corresponding clauses in IEC 60335-1, so as to convert that publication into the IEC standard: Safety requirements for portable electric immersion heaters.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification", or "replacement", the relevant text in Part 1 is to be adapted accordingly.

NOTE 2 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.

NOTE 3 The following print types are used:

- requirements: in roman type;
- test specifications: in italic type;
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3. When a definition concerns an adjective, the adjective and the associated noun are also in bold.

The following differences exist in the countries indicated below

- 19.2: The test is carried out with the appliance suspended by its supply cord (Poland).
- Clause 21: The additional test is only carried out on appliances with a non-metallic enclosure (USA).
- 24.101: This requirement is not applicable (NSA).

The committee has decided that the contents of the base publication and its amendments will remain unchanged until the maintenance result date indicated on the IEC web site under "http://webstore.iec.ch" in the data related to the specific publication. At this date, the publication will be

- reconfirmed,
- withdrawn,
- replaced by a revised edition, or
- amended.

NOTE The attention of National Committees is drawn to the fact that equipment manufacturers and testing organizations may need a transitional period following publication of a new, amended or revised IEC publication in which to make products in accordance with the new requirements and to equip themselves for conducting new or revised tests.

It is the recommendation of the committee that the content of the amendment 2 be adopted for implementation nationally not earlier than 12 months or later than 36 months from the date of publication.

#### INTRODUCTION

It has been assumed in the drafting of this International Standard that the execution of its provisions is entrusted to appropriately qualified and experienced persons.

This standard recognizes the internationally accepted level of protection against hazards such as electrical, mechanical, thermal, fire and radiation of appliances when operated as in normal use taking into account the manufacturer's instructions. It also covers abnormal situations that can be expected in practice and takes into account the way in which electromagnetic phenomena can affect the safe operation of appliances.

This standard takes into account the requirements of IEC 60364 as far as possible so that there is compatibility with the wiring rules when the appliance is connected to the supply mains. However, national wiring rules may differ.

If an appliance within the scope of this standard also incorporates functions that are covered by another part 2 of IEC 60335, the relevant part 2 is applied to each function separately, as far as is reasonable. If applicable, the influence of one function on the other is taken into account.

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces are not applicable in addition to Part 1 or part 2 standards.

An appliance that complies with the text of this standard will not necessarily be considered to comply with the safety principles of the standard if, when examined and tested, it is found to have other features that impair the level of safety covered by these requirements.

An appliance employing materials or having forms of construction differing from those detailed in the requirements of this standard may be examined and tested according to the intent of the requirements and, if found to be substantially equivalent, may be considered to comply with the standard.

## HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

## Part 2-74: Particular requirements for portable immersion heaters

#### 1 Scope

This clause of Part 1 is replaced by the following.

This International Standard deals with the safety of **portable electric immersion heaters** for household and similar purposes, their **rated voltage** being not more than 250 V.

Appliances not intended for normal household use but which nevertheless may be a source of danger to the public, such as appliances intended to be used by laymen in shops, in light industry and on farms, are within the scope of this standard.

As far as is practicable, this standard deals with the common hazards presented by appliances that are encountered by all persons in and around the home. However, in general, it does not take into account

2 - persons (including children) whose

- physical, sensory or mental capabilities; or
- lack of experience and knowledge

prevents them from using the appliance safely without supervision or instruction;

- children playing with the appliance.

NOTE 101 Attention is drawn to the fact that

- on for appliances intended to be used in vehicles or on board ships or aircraft, additional requirements may be 4-2002 necessary;
- in many countries, additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour and similar authorities.

NOTE 102 This standard does not apply to

- appliances intended exclusively for industrial purposes;
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas);
- heating elements incorporated in portable appliances, such as appliances for heating liquids (IEC 60335-2-15);
- aquarium heaters (IEC 60335-2-55);
- fixed immersion heaters (IEC 60335-2-73).

## 2 Normative references

This clause of Part 1 is applicable.

#### 3 Definitions

This clause of Part 1 is applicable except as follows.

#### 3.1.9 Replacement:

#### normal operation

operation of the appliance in a vessel filled with water to the minimum depth of immersion

## 4 General requirement

This clause of Part 1 is applicable.

#### 5 General conditions for the tests

This clause of Part 1 is applicable except as follows.

#### **5.3** Addition:

The additional test of 21.1 is carried out before the tests of Clause 8.

#### 6 Classification

This clause of Part 1 is applicable except as follows.

#### **6.2** Addition:

Immersion heaters shall be at least IPX7.

## 7 Marking and instructions

This clause of Part 1 is applicable except as follows.

## 7.1 Addition:

Appliances shall be marked with the maximum and minimum depths of immersion.

NOTE 101 The depths of immersion may be indicated by lines only, provided that they are explained in the instructions.

NOTE 102 The marking is not required on appliances intended to float.

#### 7.12 Addition:

The instructions shall include the substance of the following:

- details of suitable vessels to be used;
- unplug the immersion heater before removing it from the liquid;
- after unplugging, the heating element will remain hot and should not be touched or placed on combustible surfaces.

The instructions shall state that the appliance is not intended to be operated by means of an external timer or a separate remote-control system.

## 8 Protection against access to live parts

This clause of Part 1 is applicable.

## 9 Starting of motor-operated appliances

This clause of Part 1 is not applicable.

## 10 Power input and current

This clause of Part 1 is applicable.

## 11 Heating

This clause of Part 1 is applicable except as follows.

#### 11.7 Addition:

Appliances are operated for 15 min after the water temperature has reached 95 °C. However, if this temperature cannot be attained, the immersion heater is operated for 15 min after the water temperature has stabilized, or for 15 min after a thermal control has operated.

This clause of Part 1 is applicable.

## 18 Endurance

This clause of Part 1 is not applicable.
