Add Annex ZB.

2 Modification to the Foreword

Replace the fifth paragraph with the following:

"For relationship with EU Directive(s), see informative Annexes ZA and ZB, which are integral parts of this document."

3 Modification to Clause 2, Normative references

Replace "EN ISO 2867:1998, Earth-moving machinery - Access systems (ISO 2867:1994)" with "EN ISO 2867:2006, Earth-moving machinery - Access systems (ISO 2867:2006)".

4 Modification to 5.2.1, General

Replace "EN ISO 2867:1998" with "EN ISO 2867:2006".

5 Modification to 5.2.3, Alternative egress opening (emergency exit)

Replace "EN ISO 2867:1998" with "EN ISO 2867:2006".

6 Modification to 5.5.2, Falling object protective structures (FOPS)

Replace the second paragraph with the following:

"Machines with an operating mass less than or equal to 700 kg according to ISO 6016:1998 shall be fitted with a falling-object protective structure (FOPS), when they are intended for applications where there is a risk of falling objects. If FOPS is fitted, it shall meet the performance requirements of EN ISO 3449:2005 Level 1."

Relationship between this European Standard and the Essential Requirements of EU Directive 2006/42/EC
