*Replace the 3<sup>rd</sup> and 4<sup>th</sup> paragraphs with the following:*

"This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive(s).

For relationship with EU Directive(s), see informative Annexes ZA and ZB, which are integral parts of this document."

*Replace the 5<sup>th</sup> paragraph with the following:*

"The series "*Machines for the manufacture of constructional products from concrete and calcium – silicate – Safety*" consists of following parts:

Part 1: Common requirements

Part 2: Block making machines

Part 3: Slide and turntable machines

Part 4: Concrete rooftile making machines

Part 5.1: Concrete pipe machines manufacturing in the vertical axis.

*Delete the last but one paragraph.*

## 2 Modifications to the Introduction

*Replace the existing text with the following:*

"This European Standard is a Type C-standard as stated in EN ISO 12100.

The machinery concerned and the extent to which hazards, hazardous situation and events are covered are indicated in the scope of this document.

When provisions of this type C document are different from those, which are stated in type A or B documents, the provisions of this type C document take precedence over the provisions of the other documents, for machines that have been designed and built according to the provisions of this type C document.

This document specifies the additional requirements to and/or the deviations from EN 12629-1:2000+A1:2010 specific for the machines and equipment for the manufacture of constructional products from calcium silicate (and concrete) as described in 1.1.

With the aim of clarifying the intentions of the document it should be noticed that the following assumptions were made when producing it:

- specific conditions of use or environmental conditions out of the scope of the document shall be the subject of negotiations between the manufacturer and the user/owner,
- the equipment will only be used by competent and designated persons,
- the place of use/installation is adequately lit,
- all operations are carried out by specially trained operators."

## 3 Modifications to Clause 1 (Scope)

*Sub-clause 1.1, replace the existing text with the following:*

**1.1** "This part of EN 12629, taken together with EN 12629-1:2000+A1, applies to hydraulic machines for the manufacture of bricks, blocs and elements of calcium-silicate (as illustrated in Annexes A and B).

NOTE Calcium-silicate can be replaced by concrete.

EN 12629-1:2000+A1 specifies general requirements applicable to machines for the manufacture of constructional products from concrete and calcium-silicate.

This document specifies the additional requirements to and/or the deviations from EN 12629-1:2000+A1 specific to the machines it covers."

*Sub-clause 1.2, replace the existing text with the following:*

**1.2** "This European Standard deals with all significant hazards pertinent to these machines, when they are used as intended and under conditions of misuse which are reasonably foreseeable by the manufacturer (see Clause 4). This European Standard specifies the appropriate technical measures to eliminate or reduce risks arising from the significant hazards.

Noise hazard and vibration hazard are considered as not significant for those machines."

*Delete sub-clause 1.4.*

**EN 12629-8:2002/FprA1:2010 (E)**

*Delete sub-clause 1.5.*

*Sub-clause 1.6, replace the existing text with the following:*

**1.4** "This document is not applicable to machines and equipment for the manufacture of constructional products from calcium silicate (and concrete), which are manufactured before the date of publication of this document by CEN."

**4 Modifications to Clause 2 (Normative references)**

*Replace the existing text with the following:*

"The following referenced documents are indispensable for the application of this document. For dated references, only the edition cited applies. For undated references, the latest edition of the referenced document (including any amendments) applies.

EN 12629-1:2000+A1:2010, *Machines for the manufacture of constructional products from concrete and calcium-silicate - Safety - Part 1: Common requirements.*

EN ISO 12100-1:2003, *Safety of machinery — Basic concepts, general principles for design — Part 1: Basic terminology, methodology (ISO 12100-1:2003)*

EN ISO 12100-2:2003, *Safety of machinery — Basic concepts, general principles for design — Part 2: Technical principles (ISO 12100-2:2003)*"

**5 Modifications to Clause 3 (Terms and definitions)**

*First and second paragraphs, replace the existing text with the following:*

"For the purposes of this document, the terms and definitions given in EN ISO 12100-1:2003, EN 12629-1:2000+A1:2010 and the following apply."

**6 Modifications to Clause 4 (List of significant hazards)**

*Delete the second paragraph.*

*Sub-clause 4.1, second paragraph update as follows:*

*Replace "EN 12629-1:2000" with "EN 12629-1:2000+A1:2010".*

**7 Modifications to Clause 5 (Safety requirements and/or measures)**

*Replace the headline with the following:*

"Safety requirements and/or protective measures"



*Hanging paragraphs, replace the existing text with the following:*

"Machinery shall comply with the safety requirements and/or protective measures of this clause and, unless otherwise specified in this standard, with the relevant requirements of EN 12629-1:2000+A1. In addition, the machine shall be designed according to the principles of EN ISO 12100 for hazards relevant but not significant, which are not dealt with by this document.

NOTE For hazards which are to be reduced by the application of an A or B-level standard such as EN ISO 13850, EN ISO 13857, EN 60204-1, and for hydraulic, pneumatic or other machinery dealt with in standards for common uses, the manufacturer should carry out a risk assessment to establish the requirements of the A or B-level or other standard which are to be applied. This specific risk assessment should be part of the general risk assessment of the machine.

Where it is known that the installation site already contains elements that can be considered as risk reduction means, the design of the machine may take these elements into consideration (see also Clause 7)."

*Sub-clause 5.1, first paragraph, replace "EN 12629-1:2000" with "EN 12629-1:2000+A1:2010".*

*Sub-clause 5.1, Table 2 (headline – 4<sup>th</sup> column), update as follows:*

*Replace "5 of EN 12629-1:2000" with "Clause 5 of EN 12629-1:2000+A1:2010".*

*Sub-clause 5.3, update as follows:*

*Replace "EN 12629-1:2000" with "EN 12629-1:2000+A1:2010".*

## **8 Modifications to Clause 6 (Verification of safety measures and/or provisions)**

*Replace the headline with the following:*

"Verification of safety requirements and/or protective measures"

*Second paragraph, update as follows:*

*Replace "EN 12629-1:2000" with "EN 12629-1:2000+A1:2010".*

*Table 3, last column, update as follows:*

*Replace "3.23.6 of EN 292-1:1991" with "3.26.7 of EN ISO 12100-1:2003".*

## **9 Modifications to Clause 7 (Information for use)**

*First paragraph, update as follows:*

*Replace "EN 12629-1:2000" with "EN 12629-1:2000+A1:2010".*

*Penultimate paragraph, replace the existing text with the following:*

"Where the means of reducing the risk is to be achieved by the arrangement or positioning of the installed machine (e.g. protection by a wall of the building), the manufacturer shall explain, in the instruction handbook, the means to be provided and if appropriate, the means of verification."
