Foreword

This document (EN 1870-5:2002/prA1:2009) has been prepared by Technical Committee CEN/TC 142 "Woodworking machines - Safety", the secretariat of which is held by UNI.

This document is currently submitted to the Unique Acceptance Procedure.

This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of the Machinery Directive.

For relationship with EU Directive, see informative Annexes ZA and ZB, which are integral parts of this document.

1 Modification to the Foreword

Replace the fourth paragraph with the following:

"For relationship with EU Directive(s), see informative Annexes ZA and ZB, which are integral parts of this document.".

In the 6th paragraph, replace "Annexes F, G and ZA" with "Annexes G, ZA and ZB".

2 Modification to Clause 1, Scope

Replace first paragraph with: "This document deals with the significant hazards, hazardous situations and events as listed in Clause 4 which are relevant to circular saw benches/up-cutting cross-cut sawing machines, hereinafter referred to as "machines", designed to cut solid wood, chipboard, fibreboard, plywood and also these materials where they are covered with plastic edging and/or plastic/light alloy laminates."

Replace the first indent of the second paragraph with:

"- hand-held motor-operated electric tools or any adaptation permitting their use in a different mode, i.e. bench mounting;"

and add the following note: "NOTE 1 Hand-held motor-operated electric tools and saw benches to form an integrated whole with a hand-held motor-operated electric tools are covered by EN 60745-1:2006 together with EN 60745-2-5:2007."

Replace the second indent of the second paragraph with:

"- machines set up on a bench or a table similar to a bench, which is intended to carry out work in a stationary position, capable of being lifted by one person by hand."

and add the following note: "NOTE 2 Transportable motor-operated electric tools are covered by the requirements of EN 61029-1:2000 together with EN 61029-2-1:2002."

3 Modification to Clause 2, Normative references

Replace the standard paragraph with the following: "The following referenced documents are indispensable for the application of this document. For dated references, only the edition cited applies. For undated references, the latest edition of the referenced document (including any amendments) applies.".

Delete reference EN 292-1:1991 in Clause 2 and replace "EN 292-1:1991" with "EN ISO 12100-1:2003" throughout the document.

Delete references EN 292-2:1991 and EN 292/A1:1995.

Delete reference EN 294:1992 and replace it with "EN ISO 13857:2008, Safety of machinery - Safety distances to prevent hazard zones being reached by upper and lower limbs (ISO 13857:2008)". In 5.2.7.3 replace "EN 294:1992" with "EN ISO 13857:2008".

Replace reference to "EN 847-1:1997" with "EN 847-1:2005" throughout the document and its title with the following: "Tools for woodworking — Safety requirements — Part 1: Milling tools, circular saw blades"

Delete reference EN 954-1:1996 and replace it with "EN ISO 13849-1:2008, Safety of machinery — Safety-related parts of control systems — Part 1: General principles for design (ISO 13849-1:2006)". Replace "EN 954-1:1996" with "EN ISO 13849-1:2008" throughout the text.

Replace "EN 60204-1:1992" with "EN 60204-1:2006" and replace in the title "(IEC 60204-1:1992, modified)" with "(IEC 60204-1:2005, modified)".

Replace the title of EN 60825-1 with "Safety of laser products — Part 1: Equipment classification and requirements (IEC 60825-1:2007)".

Replace "EN 60947-4-1" with "EN 60947-4-1:2001" throughout the document and replace in the title "(IEC 60947-4-1:1990)" with "(IEC 60947-4-1:2000)".

Replace "EN 60947-5-1:1997" with "EN 60947-5-1:2004" throughout the document and replace in the title "(IEC 60947-5-1:1990)" with "(IEC 60947-5-1:2003)".

Replace "EN 61029-1:1996" with "EN 61029-1:2000" throughout the document and replace in the title "(IEC 1029-1:1990, modified)" with "(IEC 61029-1:1990, modified)".

Replace the title of EN ISO 3743-2 with "Acoustics — Determination of sound power levels of noise sources using sound pressure — Engineering methods for small, movable sources in reverberant fields — Part 2: Methods for special reverberation test rooms (ISO 3743-2:1994)".

Replace the title of EN ISO 3744 with "Acoustics — Determination of sound power levels of noise sources using sound pressure — Engineering method in an essentially free field over a reflecting plane (ISO 3744:1994)".

Replace reference to "ISO 3745" with "EN ISO 3745:2003, Acoustics — Determination of sound power levels of noise sources using sound pressure — Precision methods for anechoic and semi-anechoic rooms (ISO 3745:2003)" and replace "ISO 3745:1997" with "EN ISO 3745:2003" throughout the document.

Replace the title of EN ISO 3746 with "Acoustics — Determination of sound power levels of noise sources using sound pressure — Survey method using an enveloping measurement surface over a reflecting plane (ISO 3746:1995)".

Replace the title of EN ISO 11202 with "Acoustics - Noise emitted by machinery and equipment - Measurement of emission sound pressure levels at a work station and at other specified positions - Survey method in situ (ISO 11202:1995)".

Replace reference to "HD 21.1 S3" with "HD 21.1 S4:2002, Cables of rated voltages up to and including 450/750 V and having thermoplastic insulation — Part 1: General requirements" and replace "HD 21.1 S3" with "HD 21.1 S4:2002" throughout the document.

Replace reference to "HD 22.1 S3" with "HD 22.1 S4:2002, Cables of rated voltages up to and including 450/750 V and having cross-linked insulation — Part 1: General requirements" and replace "HD 22.1 S3" with "HD 22.1 S4:2002" throughout the document.

Replace reference to "HD 22.4 S3" with "HD 22.4 S4:2004, Cables of rated voltages up to and including 450/750 V and having crosslinked insulation — Part 4: Cords and flexible cables" and replace "HD 22.4 S3" with "HD 22.4 S4:2004" throughout the document.

Add the following references:

4 Modification to 3.2, Definitions

Definition 3.2.4, replace the term with "displaceable machine".

Definition 3.2.13, replace the term with "information from the supplier".

5 Modification to Clause 4, List of hazards

Replace the clause content with:

"This clause contains the significant hazards, hazardous situations and events (see EN 1050:1996) as far as they are dealt with in this document, identified by risk assessment as significant for the machines as defined in the scope and which require action to eliminate or reduce the risk. This document deals with these significant hazards by defining safety requirements and/or measures or by reference to relevant standards.

These hazards are listed in Table 1 in accordance with Annex A of EN 1050:1996.
