This draft amendment is submitted to CEN members for unique acceptance procedure. It has been drawn up by the Technical Committee CEN/TC 142.

This draft amendment A1, if approved, will modify the European Standard EN 848-1:2007. ## Foreword

This document (EN 848-1:2007/FprA1:2008) has been prepared by Technical Committee CEN/TC 142 "Woodworking machines - Safety", the secretariat of which is held by UNI.

This document is currently submitted to the Unique Acceptance Procedure.

This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of the Machinery Directive.

For relationship with EU Directive(s), see informative Annexes ZA and ZB, which are integral parts of this document.

#### EN 848-1:2007/FprA1:2009 (E)

#### **1** Modification to the French title

In the 3<sup>rd</sup> element of the title, replace "à broche verticale" with "à arbre vertical".

#### 2 Modification to the Foreword

Replace the fifth paragraph with the following:

"For relationship with EU Directive(s), see informative Annexes ZA and ZB, which are integral parts of this document.".

Add the following new standards list: "

EN 848 Safety of woodworking machines — One side moulding machines with rotating tool consists of the following parts:

Part 1: Single spindle vertical moulding machines

Part 2: Single spindle hand fed/integrated fed routing machines

Part 3: Numerically controlled (NC) boring and routing machines".

#### 3 Modification to Clause 1, Scope

In NOTE 3, replace "prEN 61029-2-8:2003" with "EN 61029-2-8:2003".

#### 4 Modification to Clause 2, Normative references

Replace the reference EN 61310-1:1995 with "EN 61310-1:2008, Safety of machinery — Indication, marking and actuation — Part 1: Requirements for visual, auditory and tactile signals (IEC 61310-1:2007)".

Delete reference EN 294:1992 and replace it with "EN ISO 13857:2008, Safety of machinery — Safety distances to prevent hazard zones being reached by upper and lower limbs (ISO 13857:2008)". Replace "EN 294:1992" with "EN ISO 13857:2008" throughout the document.

*Replace* "EN ISO 13849-1:2006" *with* "EN ISO 13849-1:2008" *and* "EN ISO 13849-2:2003" *with* "EN ISO 13849-2:2008" *in Clause 2 and throughout the document.* 

#### 5 Modification to 5.4.5, Ergonomics and handling

*After the last sentence of the 6<sup>th</sup> paragraph, add the following*: "These attachments shall be positioned such as to avoid machine or components overturn or fall or move in an uncontrolled way during transport, assembly, dismantling, disabling and scrapping.".

#### 6 Modification to 6.2, Marking

*Replace the text in a) with the following:* "business name and address of the machine manufacturer and, where applicable, of his authorised representative;".

*Replace the text in b) with the following:* "year of construction, that is the year in which the manufacturing process is completed;".

Replace the text in c) with the following: "designation of the machinery and designation of series or type;".

In the 3<sup>rd</sup> paragraph below Figure 20, replace "Table 6 of EN 61310-1:1995" with "Table A.1 of EN 61310-1:2008".

#### 7 Modification to 6.3, Instruction handbook

Add in v) the following NOTE:

"NOTE Information on noise emission should also be provided in the sales literature.".

Add new: "w) information on conditions necessary to ensure that throughout the foreseeable lifetime the machine including its components cannot overturn or fall or move in an uncontrolled way during transport, assembly, dismantling, disabling and scrapping;".

*Add new: "x*) the operating method to be followed in the event of accident or breakdown; if a blockage is likely to occur, the operating method to be followed so as to enable the equipment to be safely unblocked;".

Add new: "y) the specifications of the spare parts to be used, when these affect the health and safety of operators.".

#### 8 Modification to Annex ZA

In the second paragraph, delete the bracket expression "(except Annex F)" and in Table ZA.1, replace reference to "Annex F" with "5.2.1.3" in the row for Essential Requirement 1.2.8.

#### 9 Addition of Annex ZB

Add the following new Annex ZB:
