Foreword

This document (EN 848-3:2007/prA1:2009) has been prepared by Technical Committee CEN/TC 142 "Woodworking machines - Safety", the secretariat of which is held by UNI.

This document is currently submitted to the Unique Acceptance Procedure.

This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of the Machinery Directive.

For relationship with EU Directive(s), see informative Annexes ZA and ZB, which are integral parts of this document.

1 Modification to the Foreword

Replace the fifth paragraph with the following:

"For relationship with EU Directive(s), see informative Annexes ZA and ZB, which are integral parts of this document.".

2 Modification to Clause 2, Normative references

Delete the reference to EN 294:1992 and add "EN ISO 13857:2008, Safety of machinery — Safety distances to prevent hazard zones being reached by upper and lower limbs (ISO 13857:2008)" and replace "EN 294:1992" with "EN ISO 13857:2008" throughout the document.

3 Modification to 5.4.5, Ergonomics and handling

Add at the end of 4th paragraph: "These attachments shall be positioned such as to avoid machine or components overturn or fall or move in an uncontrolled way during transport, assembly, dismantling, disabling and scrapping.".

4 Modification to 6.2, Marking

Replace the text in a) with the following: "business name and address of the machine manufacturer and, where applicable, of his authorised representative;".

Replace the text in b) with the following: "year of construction, which is the year in which the manufacturing process is completed;".

Replace the text in c) with the following: "designation of the machinery and designation of series or type;".

Delete d) and renumber the following items.

5 Modification to 6.3, Instruction handbook

Add in I) the following NOTE:

"NOTE 1 Information on noise emission should also be provided in the sales literature.".

In o), replace "NOTE" with "NOTE 2".

Add new: "s) information on conditions necessary to ensure that throughout the foreseeable lifetime the machine including its components cannot overturn or fall or move in an uncontrolled way during transport, assembly, dismantling, disabling and scrapping;".

Add new: "t) the operating method to be followed in the event of accident or breakdown; if a blockage is likely to occur, the operating method to be followed so as to enable the equipment to be safely unblocked;".

Add new: "u) the specifications of the spare parts to be used, when these affect the health and safety of operators.".

6 Modification to Annex ZA

In the second paragraph, replace "(except Annex F)" with ", except Annex F,", add "given in Table ZA.1" after "normative clauses of this standard", in the title replace "Table ZA" with "Table ZA.1" and in Table ZA.1, delete ", Annex F" in lines 1.2.8 and 1.5.11, replace "5.4.8" with "5.4.10" in row 1.5.11 and add "5.2.1.3" in row 1.2.8 and deleted the last column.

7 Addition of Annex ZB

Add the following new Annex ZB:
