Foreword

This document (EN 71-1:2005/FprA9:2009) has been prepared by Technical Committee CEN/TC 52 "Safety of toys", the secretariat of which is held by DS.

This document is currently submitted to the Unique Acceptance Procedure.

This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EC Directive(s).

For relationship with EC Directive(s), see informative Annex ZA, which is an integral part of this document.

EN 71-1:2005/FprA9:2009 (E)**1 Modification to 3.15**

Amend the definition 3.15 by adding the underlined text as follows:

"material intended to be wholly contained within a soft-filled toy or within soft-filled parts of a toy".

2 Modification to 4.5

Add a new point d) as follows:

"d) it is in the form of other glass elements (e.g. glass beads) that after being subjected to 8.5 (drop test) and 8.7 (impact test) do not expose accessible hazardous sharp edges (see 8.11, sharpness of edges) or hazardous sharp points (see 8.12, sharpness of points)."

3 Modification to 5.1

Add the following text after the last indent:

"However, tightly packed, stuffed components made of fabric and/or yarn are not excluded from the general requirements of 5.1."

4 Modification to 5.12

Replace in the first paragraph of clause 5.12 "...with the minor and major outer diameters between...", with

"...with the minor and major inner dimensions between...".

5 Modification to 8.5

Add a reference to 4.5 in the heading as follows:

"8.5 Drop test (see 4.5, 4.6, 4.10.2, 4.14.2, 4.22, 5.1, 5.10, 5.12 and 5.13)".

6 Modification to 8.7

Add a reference to 4.5 in the heading as follows:

"8.7 Impact test (see 4.5, 4.6, 4.10.2, 4.14.2, 4.22, 5.1, 5.10, 5.12, 5.13 and A.38)".
