This draft amendment is submitted to CEN members for unique acceptance procedure. It has been drawn up by the Technical Committee CEN/TC 142.

This draft amendment A1, if approved, will modify the European Standard EN 1870-14:2007. If this draft becomes an amendment, CEN members are bound to comply with the CEN/CENELEC Internal Regulations which stipulate the conditions for inclusion of this amendment into the relevant national standard without any alteration.

This draft amendment was established by CEN in three official versions (English, French, German). A version in any other language made by translation under the responsibility of a CEN member into its own language and notified to the CEN Management Centre has the same status as the official versions.

### Foreword

This document (EN 1870-14:2007/prA1:2009) has been prepared by Technical Committee CEN/TC 142 "Woodworking machines - Safety", the secretariat of which is held by UNI.

This document is currently submitted to the Unique Acceptance Procedure.

This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of the Machinery Directive.

For relationship with EU Directiv(e), see informative Annexes ZA and ZB, which are integral parts of this document.

#### **1** Modification to the Foreword

Replace the fifth paragraph with the following:

"For relationship with EU Directive(s), see informative Annexes ZA and ZB, which are integral parts of this document.".

Delete Part 2 from the standards list.

#### 2 Modification to Clause 2, Normative references

Delete the reference to EN 294:1992 and add "EN ISO 13857:2008, Safety of machinery — Safety distances to prevent hazard zones being reached by upper and lower limbs (ISO 13857:2008)" and replace "4.5.1 of EN 294:1992" with "4.2.4.1 of EN ISO 13857:2008" throughout the document.

Replace "EN 847-1:2005+A1:2007" with "EN 847-1:2005" throughout the document.

Delete the reference to EN 61310-1:1995 and add "EN 61310-1:2008, Safety of machinery — Indication, marking and actuation — Part 1: Requirements for visual, acoustic and tactile signals (IEC 61310-1:2007)" and replace "Table 6 of EN 61310-1:1995" with "Table A.1 of EN 61310-1:2008" in the 8<sup>th</sup> paragraph of 5.4.5.

#### 3 Modification to Clause 4, List of significant hazards

In Table 1 under line 10.6, add references to 5.2.2 and 5.4.5 in the right hand column.

#### 4 Modification to 5.4.5, Ergonomics and handling

Add after the 6<sup>th</sup> paragraph: "Machines and components with a mass exceeding 25 kg shall include necessary attachments to accommodate the fitting of a lifting device e.g. lugs positioned such as to avoid their overturn or fall or move in an uncontrolled way during transport, assembly, dismantling, disabling and scrapping.".

#### 5 Modification to 6.2.1, Marking of the machine

*Replace the text of a) with:* "business name and address of the machine manufacturer and, where applicable, of his authorised representative;".

Replace the text of b) with: "year of construction, that is the year in which the manufacturing process is completed;".

Replace the text of c) with: "designation of the machinery and designation of series or type;".

#### 6 Modification to 6.3, Instruction handbook

*In k) replace the second sentence with*: "This includes precautions during setting and machining and instruction on how the following points can be satisfied:".

*Add new:* "t) information on conditions necessary to ensure that throughout the foreseeable lifetime the machine including its components cannot overturn or fall or move in an uncontrolled way during transport, assembly, dismantling, disabling and scrapping;".

*Add new:* "u) the operating method to be followed in the event of accident or breakdown; if a blockage is likely to occur, the operating method to be followed so as to enable the equipment to be safely unblocked;".

Add new: "v) the specifications of the spare parts to be used, when these affect the health and safety of operators.".

#### 7 Modification to Annex ZA

*In the second paragraph, replace:* "(except Annex G, 6.3 k) indents 1 to 3" with "except Annex G, 6.3 k) indents 1, 2, 3, 4, 11 and 12" *and delete reference to Annex G in the first column of rows 1.2.8 and 1.5.11. In the first column of row 1.2.8 add reference to 5.2.1.3.* 

#### 8 Addition of Annex ZB

Add the following new Annex ZB:
