# **Foreword**

This document (EN 13263-2:2005/prA1:2008) has been prepared by Technical Committee CEN/TC 104 "Concrete and related products", the secretariat of which is held by DIN.

This document is currently submitted to the Unique Acceptance Procedure.

This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive(s).

This amendment deletes a provision which had been included by mistake in EN 13263-2:2005.

The remaining technical content of EN 13263-2:2005 has not been changed.

At the same time Clause 2 "Normative references" and Bibliography has been updated.

#### 1 Modification to Foreword

Add new 5<sup>th</sup> paragraph:

"EN 13263-2:2005+A1:2009 contains a deletion of the second paragraph of 4.2.2.2.".

#### 2 Modification to Clause 2

Replace "EN 196-7:1989" with "EN 196-7:2007".

Delete all full stops and semicolons.

#### 3 Modification to 3.28

Replace the definition and its origin with the following:

"sample taken within a short period of time and at a fixed point from within a larger quantity, relating to the intended tests. It can be obtained by combining one or more immediately consecutive increments

[EN 196-7:2007]".

#### 4 Modification to 4.2.2.2

Delete the second paragraph (starting with "To ensure that ... ").

# 10 Modification to Bibliography

Replace the references 1, 2 and 4 with the following:

"EN 45020:2006, Standardization and related activities — General vocabulary (ISO/IEC Guide 2:2004)

EN ISO 9000:2005, Quality management systems — Fundamentals and vocabulary (ISO 9000:2005)" and

"ISO 3534-1:2006, Statistics — Vocabulary and symbols — Part 1: General statistical terms and terms used in probability".

Delete all full stops.
