Introduction

This document describes changes to ISO 19131:2007 *Geographic information* — *Data product specifications*. These changes delete the requirement to include an instance of CV_Coverage in a specification of a coverage product, replacing it with a requirement to include an application schema and a feature catalogue, as in the case of other geographic information product specifications. It adds requirements regarding the treatment of coverages in an application schema.
