This Amendment to ETS 300 514 (1994) has been produced by the Special Mobile Group (SMG) Technical Committee of the European Telecommunications Standards Institute (ETSI).

This Amendment to ETS 300 514 (1994) corresponds to the changes to GSM Technical Specification (GSM-TS) 02.81 from version 4.4.1 to version 4.5.0, as approved by TC-SMG.

This Amendment modifies page 13 of ETS 300 514 (1994).

Amendments

Page 13, subclause 2.3.11.

Replace the existing text of subclause 2.3.11 with the following new text:

Data request

The mobile subscriber can request the data of the supplementary service.

In response the following information shall be given:

- whether the service is provided for or not;
- if provided which mode is subscribed;
- if subscribed to the temporary mode, which default value.

Page 13, subclause 2.5. Teh STANDARD PREVIEW (standards.iteh.ai)

Replace the existing text of subclause 2.5 with the following new text:

A VPLMN which supports the CLIR service shall ensure that the line identity of a subscriber whose HPLMN does not support the CLIR service shall not be displayed to the called party unless the subscriber wishes so or the party has CLIR override capability. 300-42581800-000-514-a1-e1-2003
