This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive(s).

EN 958:2006/FprA1:2010 (E)**1 Modification to Clause 3, Terms and definitions**

Add a new definition 3.4:

**"3.4
deployment position**

arrangement or positioning of the energy absorbing device such that the energy absorbing systems can come into correct use in the event of climber fall arrest".

2 Modification to 4.1, Design

Add a new subclause after 4.1.3:

"4.1.4 Deployment position

The deployment position of the braking system shall be designed in such a way that it can easily be checked by visual examinations by the user."

3 Modification to 5.1, Design

Replace the text of subclause 5.1 with the following:

"Check by visual examinations that the requirements specified in 4.1.1 to 4.1.4 (4.1.4 based on the information supplied by the manufacturer) are met."

4 Modification to Clause 6, Marking

Add the following after 6 c):

- "d) indication of the deployment position of the braking system;
- e) reference to this European Standard; EN 958."

5 Modification to Clause 7, Information supplied by the manufacturer

Replace 7 c) with the following:

"c) the meaning of any marks on the product and in particular the deployment position of the braking system;"

6 Modification to Annex ZA

In the 2nd paragraph, replace "European Communities" with "European Union".
