1 Modification to clause 4.1, Table 1, Test requirements for Type 3, Type 4, Type PB [3] and Type PB [4] clothing

Delete the last row of table 1 (reference to EN 14325, clause 4.14)

Add, at the end of clause 4.1, the following note:

"NOTE 3 If resistance to heat and flame is required, the chemical protective clothing shall be tested and marked according to the appropriate standard."

2 Modification to clause 6, Information supplied by the manufacturer

Add the following indent:

"l) the warning phrase: "Flammable material. Keep away from fire".
