Proposed Changes to ISO/IEC 11801 1 st edition Draft Amendment 2 to ISO/IEC 11801

1. Add a footnote 4) to the 2 km link length specified in table 2 of 7.1.2 to read:

"When using fibre with a modal bandwidth of 160 MHz•km, the maximum distance is 1,6 km."

2. Add a footnote 1) to the 200 MHz•km modal bandwidth specified in table 22 of 8.4 to read:

"When using 160 MHz km modal bandwidth fibre the minimum requirements of table 13 in clause 7 can only be met for links up to 1,6 km."
