Introduce a new paragraph 10.2.3.9. Old 10.2.3.9 becomes 10.2.3.10 and so on.

10.2.3.9 Pressure testing on a statistical basis

Pressure testing on a statistical basis may be carried out under the following conditions:

- a) A serial production as defined in 3.8;
- b) The vessel category according to Directive 97/23/EC is not greater than I;
- c) At least 2 % of vessels shall be tested, at least 2 vessels from one fabrication batch. If the number of vessels manufactured in the batch is less than 10, at least one vessel per batch is tested.
