#### Introduction

A series of tests is used to assess the suitability of fastening systems for use in railway track.

In this European Standard a requirement for longitudinal rail restraint is included to control rail creep and pull apart in the event of a broken rail. Measurement of torsional resistance is included for use in assessing the risk of track buckling. Classes for attenuation of dynamic loading are included for use when it it is necessary to protect sleepers from vehicle induced impacts. The laboratory test for the effect of repeated loading is specified to assess the potential long term performance of the fastening in track. The test for clamping force is only suitable for laboratory use.

#### 1 Scope

This European Standard is applicable to fastening systems, in categories A - C and E as specified in EN 13481-1:2012, 3.1, for use on wood sleepers in ballasted track with maximum axle loads and minimum curve radii in accordance with Table 1.

Maximum design axle Minimum curve radius load Category kΝ m Α 130 40 В 80 180 С 260 150 Ε 150 350 The maximum axle load for categories A and B does not apply to NOTE maintenance vehicles.


For the purposes of this document, the following symbols apply

L lateral component of force transmitted by the wheel to the rail head as shown in Figure 1, in kN;

 $P_1$  component of load parallel to the base of the sleeper, in kN;

- *P*<sub>V</sub> component of load normal to the base of the sleeper, in kN;
- V vertical component of force transmitted by the wheel to the rail head as shown in Figure 1, in kN;
- X distance between the line of application of  $P_L$  and the centre of the gauge corner radius of the rail head as shown in Figure 1, in mm;
- angle between the load line and a line normal to running surface of the rails as shown in Figure 1, in  $^{\circ}$ .

#### 5 Requirements

#### 5.1 General

The following requirements apply to the fastening system when tested in conjunction with hardwood sleepers, with no free preservative on the surface, complying with EN 13145. Sleepers used for testing shall have parallel top and bottom surfaces.
