1 Modifications to 6.1

Add the following sentence as a new paragraph:

"For pull-out sliding loft ladders (see 3.2.3.2) there is no minimum measurement l_3 .".

"Table 2", 2^{nd} row called "Min.", 7^{th} column called " I_3 ", add "a" just after "0,5 I_1 "; then add the following cell with the corresponding footnote at the bottom of the table:

2 Modification to 6.9

Delete "vertical" before "distance l2".

3 Modification to 6.17

Replace the text with the following:

"If insulating and/or sealing values are given by the manufacturer for the product, the method of determination (calculated or tested) shall be given for each insulating or sealing value. The details of the declaration (calculated or tested by the manufacturer or tested by a third party) shall also be given together with the standards to which reference was made for the declaration."
