This draft amendment is submitted to CEN members for enquiry. It has been drawn up by the Technical Committee CEN/TC 207.

This draft amendment A1, if approved, will modify the European Standard EN 716-1:2008. If this draft becomes an amendment, CEN members are bound to comply with the CEN/CENELEC Internal Regulations which stipulate the conditions for inclusion of this amendment into the relevant national standard without any alteration.

This draft amendment was established by CEN in three official versions (English, French, German). A version in any other language made by translation under the responsibility of a CEN member into its own language and notified to the CEN Management Centre has the same status as the official versions.

Foreword

This document (EN 716-1:2008/prA1:2010) has been prepared by Technical Committee CEN/TC 207 "Furniture", the secretariat of which is held by UNI.

This document is currently submitted to the CEN Enquiry.

The following modifications shall be included in the text of EN 716-1:2008 (E).

3.5

Delete the existing text of the definition, and insert:

when a child's hand can neither reach through sides nor ends, accessible parts are the inside of the cot and the exterior of the cot 300 mm from the upper part of the rim. When a child's hand can reach through sides or ends, accessible parts are the whole cot except the underside of the cot base

4.3.1.3

Delete the existing text, and insert:

"Glued labels and decals shall not be used on the internal surfaces of cot sides and ends unless they are below the level of the cot base or mattress base."

4.3.3

Delete the first sentence, and insert:

"The following requirements do not apply to cots that have mesh or fabric sides/ends and a rigid leg or support system, when the lowest part of the opening is less than 100 mm from the floor."

4.3.7.1

Delete the existing text, and insert:

"Any cot base or mattress base that folds shall not fold if a force of 50 N is applied in the direction most likely to cause folding the cot base or mattress base."

4.3.7.3

Delete the existing text, and insert:

"When tested in accordance with 5.6 of EN 716-2:2008 the cot base shall not become dislodged and there shall be no damage that impairs the function or safety of the cot."

4.3.8.3

Delete the existing first paragraph, and insert the following text as first paragraph:

"When tested in accordance with 5.7.1, 5.7.2 and 5.7.3 of EN 716-2:2008, the slats or sides and ends and corners shall not become detached and there shall be no damage that impairs the function or safety of the cot."

4.3.8.4

Delete the existing first paragraph, and insert the following text as first paragraph:

"When tested in accordance with 5.8.1 and 5.8.2 of EN 716-2:2008, there shall be no damage that impairs the function or safety of the cot."

Insert the following A-deviation as Annex A (informative).

Annex A (informative)

A-deviations

A- deviation: National deviation due to regulations, the alteration of which is for the time being outside the competence of the CEN/ CENELEC member.

This European Standard does not fall under any Directive of the EU. In the relevant CEN/ CENELEC countries these A- deviations are valid instead of the provisions of the European Standard until they have been removed.

SWEDEN:

In Sweden, the guideline for infants' cots KOVFS 1980 : 3 (the guideline of the National Swedish Board for Consumer Policies) requests that the distance between two adjacent slats of the bed base shall be < 25 mm.

On 1991/10/28, in a court case this was enforced so that KOVFS 1980: 3 is equal to national legislation for infants' cots concerning the distance between adjacent slats of the bed base.

Consequently, the requirements in 4.3.2.5 of this standard will have to be supplemented, in Sweden, by the following: "The distance between two adjacent slats of the bed base shall be \leq 25 mm".
