1 Modification to 5.3.7, Load bearing

Replace its title "Load bearing" with the new title "Load bearing capacity on the roof".

Delete the text:

"Installation guidelines shall recommend not to permit walking between the purlins (load bearing capacity is not covered by this product standard).",

replace with the following text and add a NOTE to read:

"Load bearing capacity depends on the method of support and fixing, which are not included in the scope of this product standard.

NOTE The load level, the levels of safety and permissible deflection are defined in EUROCODES and/or national building regulations.".

2 Modification to ZA.1, Scope and relevant clauses
