1 Modification to the Scope

In the 2nd paragraph, replace the 2nd sentence "It is not applicable to tracking concentrating collectors." with "It is basically applicable to concentrating collectors; thermal performance testing as given in EN 12975-2:2006, subclause 6.3. (quasi dynamic testing) is also applicable to most concentrating collector designs, from stationary non-imaging concentrators as CPCs to high concentrating tracking designs.".
