Page 1, Clause 1

Delete ISO 291 as a normative reference.

Page 3, End of Subclause 3.2

Add the following text at the end of the subclause:

"When using a positive (type 2) mould, a pressure of about 5 MPa to 10 MPa shall be applied to the material."

Replace the text of the clause with the following:

"Test specimens shall be conditioned for at least 16 h at 23 °C \pm 2 °C. There is no requirement for this to be done at a particular relative humidity."
