Foreword

This document (EN 500-4:2006+A1:2009/FprA2:2010) has been prepared by Technical Committee CEN/TC 151 “Construction equipment and building material machines - Safety”, the secretariat of which is held by DIN.

This document is currently submitted to the Unique Acceptance Procedure.

This document has been prepared under a mandate given to CEN by the European Commission and the European Free Trade Association, and supports essential requirements of EU Directive.

For relationship with EU Directive, see informative Annex ZA, which is an integral part of this document.

1 Modification to the Scope

Add the following paragraph at the end:

"This part of EN 500 is not applicable for seated ride-on operated rollers with a drum width less than nominal 0,8 m."

2 Modification to 7.1, Warning signals and devices

Add the following paragraph at the end:

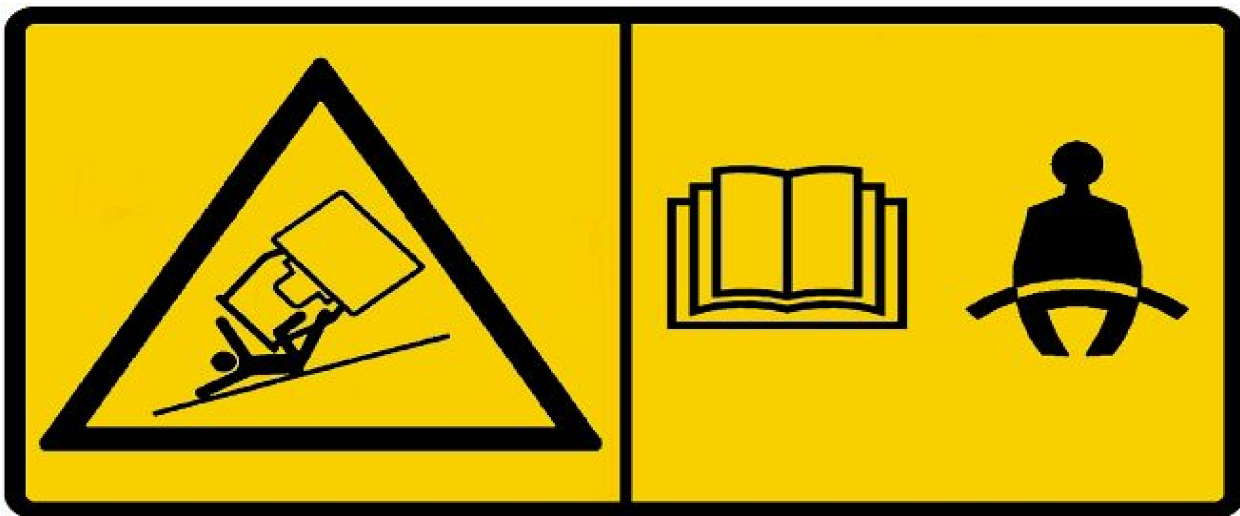


Figure 5 — Warning decal"

"For rollers with a drum width less than nominal 1 m a warning decal (see Figure 5) shall be affixed visible from the operator's station."

Add the following figure at the end:

3 Modification to 7.2, Instruction handbook

Add the following indents at the end:

- "for rollers with a drum width less than nominal 1 m the tipping angle and the applicable circumstances on the job-site which have a negative impact on the stability (e.g. height of kerbstone, dynamic influence);
- for rollers with a drum width less than nominal 1 m additional risk arises while driving close to edges (e.g. edges of kerbstones, bank, trenches, pothole) by exceeding the edge."

4 Deletion of Annex ZA

Delete Annex ZA and remember Annex ZB into Annex ZA.

In the second paragraph of new Annex ZA, replace "European Communities" with "European Union".
