AMENDMENT 1

Page 1, 5.1

Replace the first sentence of the subclause with the following.

“The support device shall be designed such that it can be installed within the machine structure so that movement of the machine, including upward and downward movement of the lift-arm linkage, cannot dislodge or disengage the support device.”

Page 1, 5.2

Replace the title and first sentence of the subclause with the following.

“5.2 Instruction for installation and removal

Installation and removal instructions as well as instructions for the storage of the support device shall be stated in the operator’s manual.”

Page 2, 5.3

Replace the entire subclause with the following.

“5.3 Storage location

If the support device is to be used for daily maintenance as recommended by the manufacturer, then the support device shall be located permanently on the machine in a secure manner.”
