1 Modification to the Foreword

Delete the following sentence "Annex B and Annex C are informative."

2 Modification to the scope

Replace the 1st until the 3rd indent with the following:

- "
- aquatic toys according to Directive 2009/48/EC (use in shallow waters / use under supervision);
- inflatable boats with a buoyancy > 1 800 N according to Directive 94/25/EC;
- buoyant aids for swimming instructions according to Directive 89/686/EEC;"

3 Modification to Clause 2 Normative references

Add the following reference:

"EN 16051-1:2011, Inflation devices and accessories for inflatable consumer products — Part 1: Compatibility of valves and valve adapters".

4 Modifications to Clause 3 "Terms and definitions"

Replace the 1st sentence with the following:

"For the purposes of this document, the terms and definitions given in EN 16051-1:2011 and the following apply."

Delete the terms and definitions from 3.18 to 3.24.

5 Modification to Clause 4 "Classification and criteria to distinguish floating leisure articles from aquatic toys"

Delete the first indent in the 2nd column "Description/Structural design criteria" for Class A, B and D

Add the following indent in the 2nd column "Description/Structural design criteria" for Class A and D

"

— The product includes use in deep water."

Replace the 1st indent of the 3rd column "Not an aquatic toy because:" of Class A with the following:

"

— provokes use in deep water; and/or due to size product is at risk to be blown into open waters and/or "

Delete the 4th indent of the 3rd column "Not an aquatic toy because:" of Class A.

Delete the 1st indent of the 3rd column "Not an aquatic toy because:" of Class B,C and D.

Delete the last indent of the 3rd column "Not an aquatic toy because:" of Class D.

6 Modification to 5.2.1 "Requirements"

Replace the existing text in 5.2.1 with the following:

"The bottom and near bottom areas of floating leisure articles shall not provide openings which may lead to foot or leg entrapment when the article is in its normal working position. This requirement is deemed to be satisfied if:

- the probe as specified in Figure 1 does not fit into any opening in the bottom (exceptions unbounded slots and openings, and slots/openings less than 50 mm in depth), and
- the probe as specified in Figure 1 does not fit in an area up to a height of 600 mm (exceptions unbounded slots and openings, and slots/openings less than 50 mm in depth).

This requirement is also satisfied if the probe specified in Figure 2 slips through continuous openings in which the probe, specified in Figure 1 fits through as well.

The height for judging the accessibility is measured from the bottom vertically upwards."

Replace the reference to Annex B with "EN 16051-1" three times.
