Add to the textbox "Typical products" for A1 the following point:

"

- Pontoons"

Replace the text in the textbox "Typical products" for A2 with the following:

"

- floating seats, arm chairs
- sit-on paddle wheel seat
- sit-on paddle cylinder
- water see saw"

Replace the 2nd column of Table 1 with the following:

"

Typical products
floating inflatable islands; recreational raft; platform/ pontoon, etc.
large buoyant structures
air mattress for use in water; floatable pool loungers; floating seating structures; giant rings / tubes

"

2 Modification to Clause 1 "Scope"

Delete the 6th indent in note 1.

3 Modification to Clause 2, Normative references

Replace "EN 15649-1:2009" with "EN 15649-1:2009+A1:2011" in Clause 2 and throughout the text.

4 Modification to 4.1 "General"

Add the following paragraph at the end of this sub-clause:

"Design and appearance of floating leisure articles shall not change the intended primary function of these floating leisure articles nor introduce a toy play value."

5 Modification to Clause 7 "Exclusions"

Add the following indent:

"- Inflatable devices of type A may display the safety information at a location starting within 200 mm from an inflation valve."

6 Modification to Annex A "Examples of typical products forming Class A"

Replace Figure A.1 with the following:

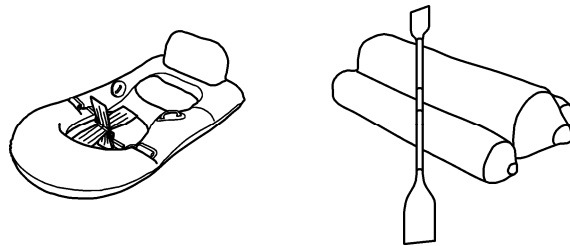


Figure A.1 — Examples of various animal and object shape ride-on"
