ISO (the International Organization for Standardization) is a worldwide federation of national standards institutes (ISO Member Bodies). Every Member Body interested in a subject for which a Technical Committee has been set up has the right to be represented on that Committee. Draft International Standards adopted by the Technical Committees are circulated to the Member Bodies for approval before their acceptance as International Standards by the ISO Council.

Prior to 1972, the results of the work of the Technical Committees were published as ISO Recommendations; these documents are now in the process of being transformed into International Standards. As part of this process, Technical IEW Committee ISO/TC 3 has reviewed ISO Recommendation R 1 and found it technically suitable for transformation. International Standard ISO 1 therefore replaces ISO Recommendation R 1-1954 to which it is technically identical.
