This draft amendment was established by CEN in three official versions (English, French, German). A version in any other language made by translation under the responsibility of a CEN member into its own language and notified to the CEN-CENELEC Management Centre has the same status as the official versions.

## **Foreword**

This document (EN 13082:2008/FprA1:2011) has been prepared by Technical Committee CEN/TC 296 "Tanks for transport of dangerous goods", the secretariat of which is held by AFNOR.

This document is currently submitted to the Unique Acceptance Procedure.

## EN 13082:2008/FprA1:2011 (E)

#### 1 Modifications to the Foreword

Delete the second sentence of the fifth paragraph:

"Therefore in this context the standards listed in the normative references and covering basic requirements of the RID/ADR not addressed within the present standard are normative only when the standards themselves are referred to in the RID and/or in the technical annexes of the ADR.".

Add as 7<sup>th</sup> paragraph the following: "

- a) Compared to EN 13082:2008 the following changes have been made:
- b) in the Foreword, the second sentence of the fifth paragraph has been deleted;
- c) in Clause 4, it has been added that the vapour transfer valve shall be provided with a means to indicate that it is open.".

## 2 Modification to Clause 4, Functions

Add the following after the second dash:

"— be provided with a means to indicate that it is open.".
