EN 1555-3:2010/FprA1:2012 (E)**1 Modification to the Foreword**

Just before the paragraph beginning with "EN 1555 consists of", add the following text:

"Due to Amendment 1 to EN 1555-3:2010, this document comprises technical changes to:

- Subclause 7.2, Requirements;
- Subclause 10.2, Minimum required marking of fittings."

2 Modification to 7.2, Requirements

In Footnote b in Table 4 — Mechanical characteristics, replace the sentence "The stress shall be calculated using the nominal dimensions of the pipe used in the test assembly." with "The test pressure shall be calculated using the design SDR of the fitting."

3 Modification to 10.2, Minimum required marking of fittings

In Table 8 — Minimum required marking, in column Aspects, on the last line, replace "Intended use^b" with "Intended use^{a,b}".
