Foreword

This document (EN 12221-1:2008/FprA1:2013) has been prepared by Technical Committee CEN/TC 252 "Child use and care articles", the secretariat of which is held by AFNOR.

This document is currently submitted to the Unique Acceptance Procedure.

1 Modification to the title

Add "Child use and care articles" to the title to read:

"Child use and care articles — Changing units for domestic use — Part 1: Safety requirements".

2 Modification to Clause 3, Terms and definition

Add the following terms and definitions after 3.1

3.1.1

type 1 changing unit

changing unit intended for use for children from birth up to an age of 12 months in accordance with the manufacturer's instructions for use

3.1.2

type 2 changing unit

changing unit intended for use for children from birth up to 15 kg".

3 Modification to 4.1, Dimensions

Add the following text:

"The length of the changing area is the intended longitudinal position of the child on the unit.

The width of the changing area is the measurement perpendicular to the length.".

4 Modification to 5.4, Locking and folding mechanism of the complete unit

Replace the last sentence with the following:

"Changing board flaps and wall mounted changing units are excluded from this requirement.".

5 Modification to Clause 7, instruction for use

Replace the text of j) with the following:

weight/age of the child for which the product is intended:

- for type 1 changing units: 12 months, up to 11 kg
- for type 2 changing units: 15 kg;".

6 Modification to Clause 8, Marking

Add the following point:

d) for Type 1 changing units, information on the maximum age and weight: 12 months up to 11 kg.".

7 Modification to Clause 9, Purchase information

Replace the text of a) with the following:

"weight/age of the child for which the product is intended:

- for type 1 changing units: 12 months, up to 11 kg
- for type 2 changing units: 15 kg;".
