Add the following safety signs:

- M028: Keep locked
- M029: Sound horn
- M030: Use litter bin
- M031: Use table saw adjustable guard
- M032: Wear anti-static footwear
- P016: Do not spray with water
- W030: Warning; Hand crushing between press brake tool
- W031: Warning; Hand crushing between press brake and material
- W033: Warning; Barbed wire
- W034: Warning; Bull
- W035: Warning; Falling objects
