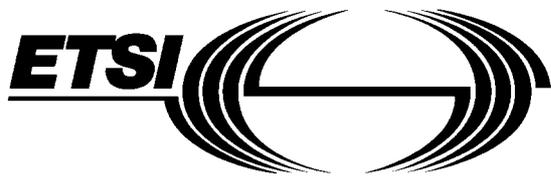

Foreword

This amendment to I-ETS 300 315 (1994) has been produced by the Signalling Protocols and Switching (SPS) Technical Committee of the European Telecommunications Standards Institute (ETSI).

I-ETS 300 315 (1994) includes additional and modified codepoints for the HLC and LLC information elements from amendment 1 (1993) to ETS 300 102-1 (1991). However, I-ETS 300 315 (1994) contains a dated reference to the unamended version of ETS 300 102-1 (1991). This amendment changes the dated reference to an undated one.

The codepoints for modem type in the Bearer Capability and Low Layer Compatibility information elements in I-ETS 300 315 (1994) differ from those in ETS 300 102-1 (1991) either with or without the amendment. For example, the codepoint for V.21 in I-ETS 300 315 (1994) is given as 33, whereas in the unamended ETS 300 102-1 (1991) it is 1 and in amendment 1 (1993) it is 17. This amendment corrects these codepoints.

I-ETS 300 315 (1994) erroneously includes the basic access codings for the Information channel selection field of the Channel ID. This amendment introduces the coding for primary rate access.
