The proposal to endorse the second edition of IEC Publication 335-2-36, document CENELEC/TC 61 (SEC) 504, was circulated under the enquiry procedure in September 1986.

This proposal was discussed during the Brussels meeting in May 1987 when it was decided to submit a draft for EN 60 335-2-36 to the voting procedure. This procedure started in September 1988.

The text of this draft was ratified by the CENELEC Technical Board on the 7th of March 1989.
