### AMENDMENT 7: Safety sign P011: Do not extinguish with water

		<b>Additional information</b> Test data obtained according to ISO 9186:2001 are not available. Consequently, a supplementary text sign shall be used to increase comprehension except when the safety sign is supplemented by manuals, instructions or training.
