#### BRIEF HISTORY

The proposal to endorse the first edition of IEC Publication 335-2-47, document CLC/TC 61 (SEC) 582, was circulated under the enquiry procedure in August 1987.

This proposal was discussed during the Neusiedl meeting in May 1988 when it was decided to submit a draft for EN 60335-2-47 to the voting procedure. This procedure started in October 1989.

The text of this draft was ratified by the CENELEC Technical Board on the 5th of March 1990.

For commercial cooking appliances and for groups of such appliances, having a total maximum rated input exceeding 20 kW, parts situated at a height not exceeding 110 cm from the floor shall be jet proof (IPX5).
