R The proposal to endorse the first edition of IEC Publication IEC 335-2-50, documents CLC/TC 61 (SEC) 690 and 690A, was circulated under the enquiry procedure in May and July 1989.

This proposal was discussed during the Stockholm meeting in November 1989 when it was decided to submit a draft for EN 60335-2-50 to the voting procedure. This procedure started in July 1990.

The text of this draft was ratified by CENELEC on the 10th of December 1990.
