#### **AMENDMENT 2**

Page v, Introduction

Replace "ISO 12100-1:2003" in the 3<sup>rd</sup> para with "ISO 12100:2010".

Page 1, Scope

Add the following sentence as second para:

This standard is complemented by the type C standards ISO 9902 (part 1 and 6) with respect to noise emission measurement and ISO/DIS 23771 with respect to measures for the reduction of noise emissions.

Clauses 1 to 7

Throughout the text, replace all the dated references "ISO 11111-1:2005" with ISO 11111-1:—".

Page 4, 5.2.1 b)

Replace list item b), number 1) and number 2), with the following:

1) sensitive protective equipment (SPE), e.g. active opto-electronic protective device(s) (AOPD), in accordance with ISO 11111-1:—, Table 3.

Reaching the hazard zone shall not be possible without activating the SPE (see Figure 1). The AOPD shall comply with type 4 according to IEC 61496-1 and IEC 61496-2. The SPE may be deactivated immediately after the machine has reached its normal production speed, unless it is used additionally to protect the danger zone between the moving sley and fixed machine parts (see 5.2.1 c);

2) Movable interlocked guards, covering the crushing area between the temple and the reed, designed to prevent finger access.

Page 6, 5.2.1 e)

Replace "emergency stop control" with "emergency stop device".

Page 6, 5.2.1 i)

Replace "emergency stopping device with "emergency stop device".

Page 12, 5.2.9 a)

Replace "emergency stop device" with "emergency stop".
