#### Introduction

The requirements of the standard are concerned with the safety-related audio input performance of the earmuffs. Sound output levels and criterion input signals are reported in the user information.

EN 352-6 is part of a family of standards describing product requirements:

#### 1 Scope

This document is applicable to earmuffs supplemented by a safety-related audio input. The audio signal can be transmitted by electrical input or other communication like Bluetooth<sup>1</sup>. It specifies requirements on construction, design, performance, marking and user information related to the inclusion of the safety-related audio input.

Earmuffs with safety-related audio input are designed to provide speech information and warning signals, while providing attenuation of external sound. They may be selected for use in a number of different environments, for example in air traffic communication, in the police forces, in the broadcasting and entertainment industries.

#### earmuffs with safety-related audio input

earmuffs including an electrical audio input facility or circuit for safety-related communication

#### 3.2

#### sound output level

A-weighted diffuse-field related sound pressure level produced by the audio input facility of an earmuff for a given input signal

#### 3.3

#### criterion input signal

mean input signal minus one standard deviation for which the sound output level is equal to 82 dB(A)

#### 4 Requirements

#### 4.1 General

Earmuffs with safety-related audio input shall meet the requirements of EN 352-1:2020 (or EN 352-3:2020, as appropriate) and the requirements listed in 4.2.

#### 4.2 Sound output levels and criterion input signal

The sound output level of the earmuffs with electrical audio input shall be measured in accordance with EN 13819-3:2019, 7.6.1.2.2. For earmuffs with Bluetooth<sup>2</sup> audio input, the sound output level shall be measured according to EN 13819-3:2019, 7.5.1.2.2.

The criterion input signal for earmuffs with electrical audio input shall be calculated according to EN 13819-3:2019, 7.6.1.2.1 and for earmuffs with Bluetooth<sup>2</sup> audio input according to EN 13819-3:2019, 7.5.1.2.1.

#### 5 Marking

The marking specified in EN 352-1:2020 (or EN 352-3:2020, as appropriate) shall be used. No additional marking is needed.

#### 6 Manufacturer's instructions and information

The information specified in EN 352-1:2020 (or EN 352-3:2020, as appropriate) and the following additional information shall be supplied with the earmuffs: 1 ch a

a) a reference to this standard EN 352-6:2020;

b) an indication that the hearing protector provides safety-related audio-input 7d0-

- c) the criterion input signal;
- d) the relationship between sound output level and input signal in 5 dB steps from a sound output level of 70 dB(A) up to the maximum input signal;
- e) the sound output level for maximum input signal;
- f) the usage time for the maximum input signal that corresponds to an equivalent sound output level of 82 dB(A) over 8 h;
- g) a method for checking, charging and changing batteries, if applicable;

- h) statements that include the following information:
  - 1) The earmuff is provided with safety-related audio input. The user should check correct operation before use. If distortion or failure is detected, the user should refer to the manufacturer's advice for maintenance.
  - 2) A warning that the output of the audio circuit of this hearing protector may exceed the exposure limit level.
  - 3) A warning that this product may not be used for entertainment since the output level is not limited to the necessary innocuousness level
