The text of document 77A(CO)41 + 41A, future edition 1 of IEC 1000-3-2, prepared by SC 77A, Low-frequency phenomena, of IEC TC 77, Electromagnetic compatibility, was submitted to the IEC-CENELEC parallel vote and was approved by CENELEC as EN 61000-3-2 on 1994-07-05.

The following dates were fixed:

- latest date by which the EN has to be implemented at national level by publication of an identical national standard or by endorsement (dop) 1995-07-01
- latest date by which the national standards conflicting with the EN have to be withdrawn (dow) 1997-01-01

For products which have complied with EN 60555-2:1987 before 1997-01-01, as shown by the manufacturer or by a certification body, this previous EN may continue to apply for placing products on the market until 2001-01-01.

FOREWORD
