Page 3, subclause 4.2.1

Insert the following paragraph after the existing Note:

For grades 2,5 and above, it is not necessary to measure particles falling into the lower size categories. To avoid unnecessary work, the largest particles should be measured initially, and compared with the requirements for the maximum number of particles and agglomerates allowable in four categories according to Table A.1.
