Need People can receive injuries to the head by falling objects or by striking objects. Findings from national testing, however, showed that in one country the graphical symbol exceeded the criteria of acceptability. Consequently, a supplementary text sign may be used to increase comprehension. If the safety sign is supplemented by manuals, instructions or training, a supplementary text sign may not be required.
